New Business:

TCT video security system: TCT, via a Zoom link, presented a security system proposal which would include video at all three museum properties. The system could provide live video, stored video for 14 days, a computer app, phone app, and people counting reports. We will have two more alarm presentations.

Network for good: Our one-year subscription will expire on February 16th. A one year subscription renewal would cost \$200 per month for the software or the software and a coach would cost \$400 per month.

Cody Airport: This is an advertising opportunity. The airport would like to put up posters advertising the Museum in Meeteetse. We would pay for posters highlighting exhibits and historic sites in our area. The airport will post them at no cost. There may be an opportunity to also put posters in the café space. Larry Todd will gather more information and report at the February meeting.
